- Rob has been Chief Executive of North East Lincolnshire Council since 2014 and the CCG since 2017. Rob is a keen advocate of system integration, partnership working and a learning culture. Rob will talk about relationships between the NHS and local government, integrated care, the journey they have been on, the progress they have made and the challenges they faced. Recognising that an area like North East Lincolnshire can and will thrive if there is a clear vision and common purpose across all sectors.

- There are key components that developing ICSs need to embrace if they are to deliver integrated care that puts the patient first and makes the best use of resources collaboratively as a system. In this session we will be discussing the critical success factors that inform plans with the clinical strategies, financial allocation and the infrastructure needed to transform siloed NHS care into integrated care.
- Malcolm and Nick will share their UK and global experience of working and developing health and social care systems and what key aspects are critical to developing successful integrated care for the UK.

- 13:45 Addressing the key determinants of health**  
*Dr Shashi Khandavalli, GP and clinical director, Chorley Central Primary Care Network*
- As well as being a GP and clinical director for Chorley Central PCN, Shashi is the clinical lead for Determinants of Health at the Integrated Care Partnership (ICP) for Preston, Chorley and South Ribble, and sits on the Chorley Council Public Service Reform Board. He has worked with the Council on pilot projects including looking at high intensity users of primary care.
- In this session Shashi will be discussing some of his current work with the ICP including the methodologies they are using to understand the population's needs, addressing the key determinants that impact on life expectancy and number of healthy life years, and is leading work to develop metrics to understand the impact of their work. The Covid-19 pandemic has shone a light on the key determinants of health in a population and Shashi is currently working with a cohort of patients looking at five key areas including housing, social isolation and mental health.

*Hashi Mohamed, Barrister, Broadcaster, Commentator and Thought Leader*

Hashi Mohamed will join us to share some of his personal journey which he reflects on in his debut book on social mobility in Britain, *People Like Us*. Hashi is one of the UK's leading junior barristers, a broadcaster at the BBC and an author who came to the UK as an unaccompanied child refugee from Kenya in the summer of 1993 and was raised exclusively on state benefits in a deprived area of North West London. Hashi will explore what his own experience can tell us about social mobility and health in Britain today, about health inequalities and the impact that other social determinants may have on healthcare.

Hashi uses his personal journey to draw powerful conclusions on devising better policy, personal resilience, focus and the ability to adapt in the pursuit of success.
